<u>Consideration of a Conditional Use Permit Allowing for a Firearms Gunsmithing</u> <u>Business as a Home Occupation in an R-2 Low Density Residential District located at</u> <u>12933 N. 184th Street</u>

Kalen Carr explained his proposal for a gun cleaning, repair and customization business in his home. The application in Bennington's jurisdiction is necessary for state and federal regulations.

Johns opened a public hearing and there were no comments.

Motion by Bridgeford, second by Dowding to approve the Conditional Use Permit as presented.

<u>Consideration of Change of Zoning adding a Clustered/Mixed Use Overlay District</u> (CMD) for a development of 12 acres on Lot 195 in the Heritage Subdivision located north and west of Rainwood Road and N. 149th Street

<u>Consideration of a Preliminary Plat for 12 acres on Lot 195 in the Heritage Subdivision</u> in an R-3 Medium Density Residential District developing 37 Lots and 3 Outlots located north and west of Rainwood Road and N. 149th Street City Engineer Julie Ogden and Mark Westergard with E & A Consulting Group presented the change in zoning and preliminary plat.

The original request for R-4 zoning was retracted. The request for a CMD Overlay enables a reduction in setbacks to accommodate villa-type single family residences, and would include five-foot side yard setbacks, a 20-foot front yard setback, and approximate 51-foot lot width. The street side yard setback requirement for corner lots per the R-3 Zoning District Regulations would be maintained.

149th Street is to be rocked and maintained by the new homeowners association for the area being platted, paved in 5-10 years by the SID, and such requirements included in the subdivision agreement.

Johns opened a public hearing and there were no comments.
