## <u>Warehouse Street Project – Final Plan Review and Authorization to Advertise and</u> Obtain Easements

This project starts at South Second Street and ends at Harvest Lane and includes removal and replacement of a 27-foot-wide street, a sidewalk on the north side of the street, storm sewer and improvements to the sanitary sewer and parking availability. Costs are estimated at \$1.24 million.

Motion by Pekny, second by Dowding to approve the final plan review and authorize advertisement and bid opening in January 2023. All voted in favor and the motion carried.

Ordinance No. 516 Amending Section 5.15 of the Bennington Zoning Regulations regarding the Clustered/Mixed Use (CMD) Overlay District
City Engineer Julie Ogden presented the proposed amendments.

Johns opened a public hearing and it was pointed out that the regulations being discussed were applicable in Bennington's city limits and one-mile zoning jurisdiction.

Motion by Dowding, second by Pekny to introduce and waive three readings of Ordinance No. 516 AN ORDINANCE AMENDING SECTION 5.15 OF THE ZONING REGULATIONS OF THE CITY OF BENNINGTON REGARDING THE CMD CLUSTERED/MIXED USE OVERLAY DISTRICT. All voted in favor and the motion carried.

Motion by Pekny, second by Dowding to approve and adopt Ordinance No. 516. All voted in favor and the motion carried.

The Design Development Plan was discussed and includes plans to bid, fundraising and sponsorships. Construction is planned for spring 2023 with fields play-ready for 2024. The City's involvement in the project will be to help move long term building along one field at a time.

#### Public Works Report

Public Works Director Jake Conley explained that the State Fire Marshall is requiring the abandonment of a fuel tank located on the north side of the Public Works garage at 15505 Warehouse Street.
